

歡迎來到亞太堅韌研究基金會第三屆國際論壇——「共築韌性 新創亞太」。

甫自三年前於達沃斯世界經濟論壇啟航後,亞堅會迅即成為國際間備受肯定的創 新政策智庫,推動跨境合作與前瞻政策。自創始至今,本會致力發掘亞太地區在 應對各項重大挑戰上的最佳實踐,將亞太觀點推向國際舞台。

今年國際論壇的主題「共築韌性、新創亞太」,正呼應了造成 2025 年全球格局 迅速重塑的關鍵議題。國際經濟格局分崩離析,氣候領導力與多邊主義日漸瓦解,伴隨著政治與社會動盪,都深刻影響我們的社會結構。在這樣一個日益動盪不安的世界中,建構韌性已不再是選項之一,而是必經之路。我們今日的作為,將決定未來社會的強韌與永續。

亞堅會的使命正是回應這項迫切需求——透過聚集來自不同領域與地區的領袖, 打造一個交流理念、融合在地洞察與全球視野的平台,進一步塑造能夠在地方及 國際各層級發揮影響力的政策架構。

在過去一年中,亞堅會的影響力大幅躍升,不僅資深學人人數倍增,亦與亞太、歐洲及北美地區的多個夥伴機構建立了全新合作關係。亞堅會的影響力持續在不同部門與地區擴散,我們的努力與成果印證了過去三年來大家共同習得的重要一課:挑戰不受國界限制,因應之道也必須跨越邊界。

作為來自台灣、澳洲與印度這個亞太多元地區之代表,我們深知包容性對話的重要性。亞太地區幅員廣大、多元複雜,不容單一解方;同時也因彼此緊密互聯,而不能各自為政。正因如此,像亞堅會國際論壇這樣的平台格外重要——它促進信任、激發創新,並凝聚穩定不確定局勢所需的共同意志。

Established in 2022, CAPRI is Taiwan's first independent, nongovernmental, nonpartisan organization dedicated to enhancing global resilience. Leveraging this unique status, CAPRI draws on the experience and dynamism of the Asia-Pacific region to conduct comparative research and promote innovative policy solutions. CAPRI bridges the gap between research and policymaking by fostering cross-sector collaboration and convening leading experts to tackle pressing issues in the region. We also launched CAPRI USA in 2024 to extend our mission's reach.

財團法人亞太堅韌研究基金會(亞堅會,CAPRI)成立於 2022 年,是台灣第一個非政府、超黨派的國際公共政策智庫,致力於提升全球韌性。憑藉這一獨特地位,亞堅會借鏡亞太地區的經驗,進行務實的比較研究並推動政策創新。亞堅會透過促進跨領域合作並召集頂尖專家,搭建研究與政策制定間的橋樑,共同因應區域內迫切的議題。亞堅會美國基金會(下稱 CAPRI USA)於 2024 年正式成立,進一步擴大了亞堅會的影響力。

International Research Partners 跨領域研究國際夥伴



CAPRI USA, an independent 501(c)(3) organization and affiliate of CAPRI, advances resilience through nonpartisan policy research on challenges facing the US and the Asia Pacific. At its launch in February 2024, CAPRI USA convened experts from CAPRI and the University of Virginia's Miller Center to discuss economic and democratic resilience in Taiwan and the US. In January 2025, CAPRI USA co-hosted a conference at Fudan University to examine the domestic factors of the US and China's foreign policy.

CAPRI USA 基金會 (下稱 CAPRI USA) 是一獨立註 冊於美國並具備 501(c)(3) 資格的非營利組織。作為亞堅會的夥伴組織,CAPRI USA 致力推動增強美國及亞太地區的韌性。2024年2月,CAPRI USA 的首場活動在維吉尼亞大學(UVA)米勒公共事務中心舉辦,共同探討台灣與美國的經濟及民主韌性。2025年1月,CAPRI USA 與美國維吉尼亞大學米勒公共事務研究中心及上海復旦大學美國研究中心合作舉辦會議,深入分析全球動盪局勢下,國內政治如何影響美中關係。



BROOKINGS

CAPRI and the Brookings Institution have collaborated to advance dialogue on Taiwan's economic resilience and regional public health. A joint webinar featuring experts from both institutions examined Taiwan's reliance on semiconductors and the need for diversification. CAPRI also led a multinational public health working group in Brookings' *Democracy in Asia* project, bringing together voices from across the region to analyze how democracies can protect population health while protecting individual liberties.

International Research Partners 跨領域研究國際夥伴



CAPRI has partnered with the National Bureau of Asian Research (NBR) on their flagship publication—the *Strategic Asia* series—contributing chapters on Taiwan's economic vulnerabilities in an era of US—China decoupling. This collaboration also led to a joint panel at our second Annual Forum, where *Strategic Asia* authors and NBR leadership explored the economic and geopolitical implications of fragmentation, underscoring the importance of trust and clarity for maintaining economic resilience in the Asia-Pacific region.

CAPRI is a founding member and the Asia-Pacific research hub of the Partnership for Health System Sustainability and Resilience (PHSSR), a nonprofit, global collaboration to build more sustainable and resilient health systems. We published reports on Taiwan, South Korea, Malaysia, and the Pacific Islands, with research on Singapore ongoing, identifying strengths, challenges, and opportunities for building stronger health systems. We also engage policy stakeholders across the region, including in Auckland, Seoul, Kuala Lumpur, and Taipei.

亞堅會是「醫療體系永續性及韌性合作夥伴(PHSSR)」的創始成員及亞太區研究中心。 PHSSR 是一個致力於推動研究、促進面向未來的 永續與具備韌性的醫療體系的非營利性全球合作倡 議。亞堅會與亞太各地夥伴合作,針對台灣、南韓、 馬來西亞與太平洋島國等地發布研究報告,深入分析各地醫療體系的優勢、挑戰與發展機會。除了研究報告之外,亞堅會、PHSSR 與在地夥伴也持續與 政策決策者積極交流互動,團隊成員親赴奧克蘭、 首爾、吉隆坡與台北等亞太城市,推動區域內的政策對話與合作。
